All tests are conducted according to Association of Official Seed Analysts (AOSA) rules.

In order to determine if seed is legally marketable and to properly label and sell seed, a Complete Test (Purity, Germination and Noxious weed exam) is required. A USA Noxious will be conducted to identify weeds that are considered noxious in any of the 50 US states.

IMPORTANT!

Regulations governing Hemp require KCIA to maintain a chain of custody of all hemp seed samples received for testing. This includes:

Certificate of THC analysis 0.3% or less) from reputable lab

Proof of licensure from issuing state

Amount (weight) of seed sample submitted

Complete contact information

SAMPLE SIZE REQUIREMENTS

AOSA Rules require the following **MINIMUM** sample sizes.

Purity/Germ/Noxious: 500 grams or 1.2 pounds

Purity/ Noxious: 500 grams or 1.2 pounds

Germination: 400 seeds

TZ: 400 seeds

Seed Count: 100 grams

TEST LENGTH (subject to current lab sample volume)

Purity/Noxious/Seed count/TZ: generally reported within 2-4 days of sample receipt.

Germination: AOSA rules require a 7-day test, however we may extend it up to an additional 7 days if dormancy is suspected in a seed lot.

Rush Service available to expedite processing.

SAMPLE RETURN POLICY

Due to the value of the seed, you may request to have your sample returned to you upon completion of the testing*. Be sure to mark the appropriate box on the submittal form. You will be billed for the shipping cost of returning the sample.

* Less all seed utilized in the germination test. The remaining seed will retain its original integrity.
