## **Procedures for Refund of KCIA Research Support Fee**

According to KCIA policy, \$.50 per acre of the certification fees is designated for support of research projects. Any applicant may request a refund of this fee. The procedures are:

- 1. Applicant shall complete KCIA Research Fee Refund Request Form.
- 2. Form(s) must be submitted to KCIA after July 1 for summer inspected crops and October 1 for fall inspected crops.
- 3. All forms must be submitted no later than November 1 of the year that the field was inspected.
- 4. Requests will be verified for eligibility.
- 5. Eligible requests will be refunded within 30 days of verification.
- 6. Refunds will first be credited to the applicants account against current charges. If the applicants' account has a credit balance, a refund check will be issued if requested on the form.
