While this will not affect most of our members as they are rarely assessed, we have made some miscellaneous fee changes in 2023. The complete fee schedule is available on our website.

First the good news! Due to federal executive branch efforts against "junk fees" there is new Consumer Financial Protection Act guidance on "Insufficient Funds" charges on depositors. We expect our financial institutions to come into compliance with this guidance and we will not need to assess this charge in the future. Therefore, once this occurs, we will be lowering our Return Check Charge to the actual fee charged against KCIA plus no more than \$15.00 per instance.

Secondly, a letter went out with Form B Statements already, but we have instituted a new fee for late production class change requests. The deadline for changing the class of a production field now aligns with the deadline for Form B Statements. The fee for any class changes after May 1<sup>st</sup> will be \$50.00 per field and can be entirely avoided with proper planning and diligent application entries on the part of our seed producers. This does not affect all applications in the event of a seed shortage emergency and is only due to the increase we have had in change requests when the field is nearing harvest or already inspected.

Finally, we were able to absorb inflation increases on label and bag costs and they will not change price in 2023.

#### Statements for Fields Applied for Certification Have Been Mailed

Statements for fields applied for certification have been mailed. The statements are for payment of field fees and field inspection fees and must be paid by May 1 to avoid penalty for overdue payment. If you have field applications submitted and do not receive a statement, please contact us immediately.

When the statement is received, be sure to review it for accuracy. Make sure the class being produced is accurate as well as the acres and variety.

If you need to cancel a field, you do so by drawing a line through the field and recalculating the total fee due. Likewise, if you need to add a field, write the pertinent information on the form and recalculate total fees. Make sure you have entered the additional field in the myFields dashboard.

The Board sets the policy for our Association. Input from members is important for the Board to function properly, so do not hesitate to contact your representative if you feel you have important issues to bring.

#### **Cancelling or Adding Fields**

The drought has been relentless for a sizable portion of Kansas. Hoped for rains, if they come, may be too late to do some wheat fields much good. Tough weather conditions such as what we are now experiencing always lead to some fields being cancelled and others added in an attempt to replace production.

As mentioned earlier in this newsletter, the Form B statement mailed last week is the first place to report a field cancellation. It is also the first place to add a field since statements have been sent. Later in the season, as inspection approaches, it is not too late to cancel a field. In fact, a field may be cancelled up to the time the inspector enters a field, then it is too late to avoid the fees. To cancel a field, list the field numbers in an email to kscrop @ kansas.net and request cancellation.

Likewise, if a good faith effort was made to meet the March 15 deadline for applications, a field or two can be added at any time to replace lost production, provided it meets all requirements for certification. Otherwise, weather is not an excuse to have missed the deadline for field application. Late-added fields will be inspected as scheduling allows; however, priority must be given to those fields already scheduled.

The important thing is to not wait until the last minute to make decisions.
